

A BYLAW TO CLASSIFY, LICENCE,
REGULATE AND GOVERN BUSINESS

The Council of the Town of Southey, in the Province of Saskatchewan,
enacts as follows:

1. Unless otherwise provided in this Bylaw all words and expressions used herein shall have the same meaning given them in the Urban Municipality Act.
2. In this Bylaw:
 - a) "Contractor" means any person who contracts or covenants to do anything for another specifically, or who makes a business of executing work according to contract.
 - b) "Tradesmen" means any person who carries on a specific trade including but is not limited to, painters, drywallers, masons, flooring installers, carpenters, plumbers, gasfitters, eavestrough installers, siding installers, insulation installers, etc.
 - c) "Journeymen" means any person who carried on a specific trade for which he or she has journeyman's status granted by the Department of Labour.
 - d) "Jobber" means one who is self employed and works alone by the hour on each job providing labour only.
 - e) "Mobile or Stationery Seller" means a transient trader who goes from place to place carrying on a business at the residence or premises of the customers and the latter means one who establishes a temporary business location in the town.
3. No person shall carry on any of the businesses set out in Appendix 1 of this bylaw within the Town unless he possesses a valid and subsisting licence for the purpose issued in accordance with the provisions of this bylaw.
4. The Administrator of the municipality is hereby authorized to issue a licence to any person carrying on a business in the Town.
 - a) Who is not assessable by the Town for the purposes of business taxation in respect of that business.
 - b) Who makes application for such licence in Form "A", Appendix 2, of this Bylaw, stating specifically the nature of his business.
 - c) Who tenders with his application the proper licence fee as contained in Appendix 1.
5. Subject to the right of council to suspend or revoke the same, as provided in the Urban Municipality Act, every licence issued hereunder shall remain in force and effect until and including the 31st. day of December in the year of issue.
6. Where a licence is issued after September 1st. of any year, the fee payable shall be reduced by 50 percent.
7. Every licence issued hereunder shall specifically state the kinds of services, goods or merchandise which the licensee is authorized to offer for sale or take orders for as the case may be and whether in the case of goods or merchandise, he may offer the same for sale by retail or by public auction or both and what hours during which the sale will be conducted.

8. Every person licenced under this bylaw shall, at all reasonable times, upon request of the Town Administrator, Licence Inspector, or Peace Officer, produce such licence for inspection purposes.
9. a) Persons required to be licenced under the provisions of this bylaw are those conducting any of the businesses, trades or callings defined in Appendix 1 of this bylaw and the licence fee payable is the fee stated for each category therein.
b) The licence fee shall be due prior to the commencement of business.
10. Any person who violates any provision of this bylaw shall be guilty of an offence and liable on summary conviction to the penalties as provided in the General Penalty Bylaw of the Town.
11. Bylaw 6-82 and all amendments thereto are hereby repealed.
12. This Bylaw shall take effect and come into force on the 1st. day of January 1995.



enacts as follows:


1. That "APPENDIX 1-2000" TO BYLAW 7-1994 be revised and

LAWYERS: \$ 100/year

ACCOUNTANTS: \$ 50/year

CATERERS: \$ 10/job
\$ 50/year

CONTRACTOR: \$ 100/year
Basement subs: \$ 20/job

GREENHOUSES: \$ 50/year

HAIRDRESSERS: \$ 100/year

HEALTH RELATED BUSINESS: \$ 50/year

HOME BUSINESSES: \$ 50/year
.....bookstores; computer repair; etc.

JOBBERs- That DO NOT have an actual place of business within the town & are not open full-time: includes trucking, gravelling, excavating, landscaping, bricklayers, stonemasons, carpenters, drywallers, roofing and metal installation of eavestroughing, carpet cleaning; furnace cleaning; cabinet work, floor covering (tile, lino & rug laying, floor finishing); painters, decorators; insulators:

\$ 10/job

\$ 50/year

BUSINESSES: Floorers, Auto Detailing, Etc. - That occupy a place of business within the town and are full-time and do not fall under assessment:

\$ 100/year

ROTOTILLING & SNOW REMOVAL: \$ 25/year

TRADESMAN & JOURNEYMAN: \$ 20/job
\$ 100/year

TRANSIENT TRADER:

"Transient trader" means a person carrying on a business in Southey that

- a) offers goods or merchandise for sale by retail or auction; or
- b) solicits any person who is not a wholesaler or retail dealer for orders for future delivery of goods or services; and who is not a person that is required to license under the "Direct Sellers Act".

Home renovations Sales \$ 50/annually
